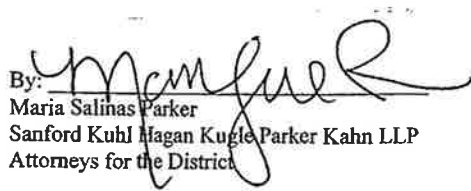
- A. Authorization of termination of water and sewer service to delinquent accounts.
